**Credit and Criminal Policy: We use third party for screening.**

We accept co-signers for credit & income **ONLY** and they must pass the criminal background checks, and Gross Income must be 4.5 times the rent.  
We do not accept subletting.

### AGE REQUIREMENT:

A person must be at least **18** years of age to enter into a lease agreement with this company.

### DOCUMENTATION REQUIRED AT APPLICATION:

All household members 18 years and older must present state/federal issued identification and social security card.

**Applicants with no social security number:** In lieu of a social security number to verify credit and criminal status such applicant may be approved with verification of employment and income. A valid passport, U.S. or Foreign, or other government photo ID and a valid work or student visa is required.

### EMPLOYMENT:

All applicants must be gainfully employed, verifiable through their company's personnel office, or have proof of adequate income from other sources. If the applicant is self-employed, a verifiable tax statement showing earnings from the previous year must be available. Applicant's gross income must equal 3 times the market rent.

### ROOMMATES:

Each roommate must complete an application and pay an application fee. The combined gross income of all roommates must equal 3 times the market rent.. Each roommate will be required to pass the credit/background check.

### CANCELLATION POLICY

At any time within 3 days of the Application, Applicant may cancel this Application by giving written notice to Management. Management will return the Admin Fee and/or the Security Deposit upon such cancellation.

If this Application is approved and the Applicant cancels after 72 hours from the date of this application, the Admin Fee and/or Security Deposit will be retained by Management in consideration for reserving the apartment.

### PET POLICY:

BREED RESTRICTIONS APPLY. We allow dogs and cats. **Maximum 2 pets**. Total 80 lbs. Dogs 50 lbs and over are subject to 1<sup>st</sup> floor only. Must have all current vaccinations/records required. **Residents must have a petscreening.com profile**. Residents are responsible for any damage to the interior or exterior of the apartment. Residents are responsible for any damages or waste from pet in common areas of the apartment community, and are required to obey all city, county, and state laws governing pets. Small fish tanks (under 25 gallons) and birds (2 maximum) allowed. **We do not accept any aggressive breeds** All pets must be pre-approved my management. We reserve the right to decline any pet or breed.

### LEASE TERMS/CLAUSES:

3-12 Month leases are offered subject to availability. Short term lease fees range from \$100-400 depending on lease term. MTM = Market rate plus \$400, 3-5 mos. = \$300, 6-8 = \$250 and 9-11 = \$100.

A FULL SIXTY (60) DAY WRITTEN NOTICE IS REQUIRED WHEN MOVING OUT. (30) DAY WRITTEN NOTICE IS REQUIRED ON ALL MONTH TO MONTH LEASES

### EARLY LEASE TERMINATION:

In order to terminate a lease before the expiration date, the resident is required to give a (30) day written notice and pay a (60) termination fee equal to two months market rent. The resident is responsible for the rent through the entire 30 days. If early termination is not selected, you are rent responsible throughout the total lease term.

### RENT:

Rent is due on the 1<sup>st</sup> day of each month. If rent is paid after the 5<sup>th</sup> day, a late fee of 5% of the rent is charged and must be paid by CASHIERS CHECK, MONEY ORDER or via our online portal. If rent is not paid by the 11<sup>th</sup> day of the month, eviction papers may be filed.

### OCCUPANCY:

Occupancy of a one bedroom is limited to two (2) persons. Two bedroom is limited to not more than four (4) persons. Three bedroom is limited to not more than (6) persons. +1 **may** be approved if relative of leasee and a minor.
