 and Venmo, a current balance inquiry is required.
- Photo ID for all adults 18 years of age and older.

RENTAL HISTORY:

The last 3 years of current rental references are checked. Verifications will be processed to determine where the applicant resides/ed and the length of time in the residence. CREDIT REQUIREMENTS:
